MOTION made by Corresponding Secretary Watson, SECONDED by Trustee Paden to:

- 1) Accept annual \$60,500 donation from the Friends of the Fullerton Public Library to be deposited in the Friends Restricted Account.
- 2) Approve spending from Friends Restricted Account funds for 2024.

# 2. Recommended Use of Bequests within the Foundation Restricted Account

**Public Comments** 

Curtis Gamble recommended contacting the County for funding for services.

No name provided – Suggested hiring part-time employees to run library sorter because of expense.

There was discussion about the Library Sorter and how it is used in the Library.

MOTION made by Trustee Paden, SECONDED by Corresponding Secretary Watson to:

- 1) Approve the use of \$50,000 from the Foundation Restricted Account to supplement the CIP funding provided by the City in the amount of \$240,000 to purchase a replacement Library Materials Sorter. Any amount not used for the purchase of the sorter shall remain in the Foundation Restricted Account when the purchase is complete.
- 2) Approve the use of \$20,000 from the Foundation Restricted Account to supplement the CIP funding provided by the City in the amount of \$5,000 to repair or replace components of the Paging (Public Address) System. Any amount not used for this purpose shall remain in the Foundation Restricted Account when the purchase complete.

Motion carried 4-0-1. Absent: Dale
