Policies & Procedures

- SB 743 does not prohibit use of LOS analysis for other purposes
- The Fullerton Plan goals, policies & actions for transportation network

- Adopt local significance thresholds for VMT for project- and cumulativelevel analysis;
- Adopt criteria to determine a project's effect on transportation using LOS;
- Adopt Transportation Assessment Policies and Procedures (TAPP) setting methods for project evaluation and the addressing of impacts or effects.



Significance Thresholds for Impacts

- CEQA allows for, and recommends specifically, for VMT
- Number of options regarding the components of the thresholds
- City consulted with Fehr & Peers and selected Fullerton-specific metrics
- Thresholds for project-level "project-generated VMT"
 - Compares project to general plan buildout
- Thresholds for cumulative-level "project's effect on VMT"
 - Compares project to citywide VMT



Criteria for Effects on Transportation

- Acceptable LOS / unacceptable LOS operating conditions originally identified in 1996 General Plan
 - ➤Acceptable LOS = D (Harbor at Chapman and Commonwealth E)
 - ➤ Unacceptable LOS = E (Harbor at Chapman and Commonwealth F)
- Effect on Transportation
 - >Acceptable becomes unacceptable
 - >Already unacceptable gets worse



Transportation Assessment Policies and Procedures

- Establishes methodology for project evaluation and content of Assessment
- Publishes VMT significance thresholds and LOS criteria for determining effects on transportation
- Conditions of approval for effects on transportation (fair share)
- Mitigation measures for impacts
- "Hand Out" for project applicants and traffic consultants



Recommended Actions

- Adopt local significance thresholds for VMT for project- and cumulative-level analysis;
- Adopt criteria to determine a project's effect on transportation using LOS;
- Adopt Transportation Assessment Policies and Procedures (TAPP) setting methods for project evaluation and the addressing of impacts or effects.
