Telephone Users: Press star-nine (\*9) on your phone to raise your hand. Press star-six (\*6) to unmute when it is your turn to address City Council.

Lower your hand if you chose not to speak or after you have made your comments by unchecking the raise hand option online.

- 2. Staff will call your name or the last four digits of your phone number when it is your time to speak.
- **3.** You may state your name and city of residence at the beginning of your remarks for the minutes.
- **4.** Speakers will have up to three minutes to make their remarks.
- **5.** You may log off or hang up after making your comments.

Those wishing to speak on a regular business or a public hearing item on this agenda may do so when the Chair calls that specific item for consideration.

Each speaker addressing the Commission may have three minutes to make their remarks. No person shall speak more than one time about the same item. The Chair may request that a spokesperson represent a group wishing to address the Commission. The Chair or majority of the Transportation and Circulation Commission may grant an extension of time for a speaker. No speaker may yield their time to another speaker.

**PERSONS ADDRESSING THE COMMISSION:** See special notice regarding Coronavirus (COVID-19) and Transportation and Circulation Commission meeting participation for instructions to participate in the meeting. State your name and city of residence for the record at the beginning of your remarks. All speakers shall observe civility, decorum, and good behavior. Any item submitted to the Commission during the meeting shall become public record and subject to applicable disclosure laws.
