## FISCAL IMPACT

No budget appropriation required. Staff estimates the annual costs to administer the Youth Advisory Committee, including meeting materials and meeting attendance totals \$9,000.

### BACKGROUND AND DISCUSSION

City Council adopted Resolution No. 2020-097 on November 2, 2020 establishing a Youth Commission to advise City Council on community youth achievements, challenges and needs. The resolution instructs the Commission to host an annual Youth in Government Day and directs the Parks and Recreation Department to provide administrative support.

The resolution establishes a monthly Commission meeting schedule between September and June. Membership consists of nine members chosen by a City Council subcommittee from the following: one Fullerton High School student, one Sunny Hills High School student, one Troy High School student, one La Vista / Sonora High School student and five at-large city residents (including one incoming Fullerton School District freshman student).

Staff presented suggested amendments to Resolution No. 2020-097 to City Council in April 2024 and City Council directed staff to meet with the Fullerton Collaborative to further refine the proposed amendments. Staff presented results of discussions with the Fullerton Collaborative to City Council on June 18, 2024 and City Council directed staff to prepare a resolution to adopt the recommendations at the July 2, 2024 meeting.

Staff presents the resolution as directed for City Council consideration. The proposed amendments include a name change, expanded committee membership, revised appointment process and additional scope of Committee duties.

Staff has updated the 2024 Youth Advisory Committee timeline as follows:

June 2024: City Council provided direction regarding Youth Advisory

Committee development

July 2, 2024: Staff presents draft resolution to City Council

• September 1, 2024: Application deadline

• September 17, 2024: City Council direct appointments

• October 1, 2024: City Council ratifies school principal appointments

October 2024: First Committee meeting.
