PURPOSE

The City of Fullerton's ~~2024-2025~~ Legislative Platform confirms the City Council's position on current issues with the potential to directly or indirectly impact the City, thereby establishing guidelines to actively pursue pending legislation through monitoring and communications activities. Below are the Guiding Principles and Policy Statements that will allow City staff to address ~~2024-2025~~ legislative and regulatory issues in a timely manner, without precluding the consideration of additional legislative and budget issues that may arise during the legislative session.

GUIDING PRINCIPLES

I. PRESERVE LOCAL CONTROL

Preserve and protect the City's powers, duties and prerogatives to enact local legislation and policy direction concerning local affairs and oppose legislation that preempts local authority. Local agencies should preserve authority and accountability for revenues raised and services provided.

II. PROMOTE FISCAL STABILITY

Support measures that promote fiscal stability, predictability, financial independence, and preserve the City's revenue base and maximum local control over local government budgeting. Oppose measures that shift local funds to the County, State or Federal Governments and/or make cities more dependent on the County, State or Federal Governments for financial stability, such as unfunded mandates or mandated costs with no guarantee of local reimbursement or offsetting benefits.

III. SUPPORT FUNDING OPPORTUNITIES

Support opportunities that allow the City to compete for its fair share of regional, state and federal funding. Support funding for programs including, but not limited to economic development such as infrastructure investment and housing, transportation projects including road resurfacing, bicycle and pedestrian safety, multi-modal transportation systems and transit-oriented development, air quality, water quality, and local water reliability, parks and recreation, historic preservation, natural resources, hazard mitigation, public safety and public health.

POLICY STATEMENTS

Administration

1. Oppose State or Federal efforts to "borrow" local revenues and encourage the State to

find other methods of balancing its budget.

2. Support local sales and use tax reform to create an equitable distribution structure that appropriately captures and allocates online sales tax.
3. Support local government action, rather than the imposition of state, federal or regional mandates upon local governments, as well as federal mandates placed on the state.
4. Support maximum flexibility for local government in contracting and contract negotiations.

- ~~8-7.~~ Support legislation that preserves the ability of local governments to determine the appropriate type of election for their jurisdiction.
- ~~9-8.~~ Monitor local, state and federal legislation pertaining to e-cigarettes.
- ~~10-9.~~ Support the preservation of Proposition 13 as stated in City Council Resolution No. 2014- 51.
- ~~11-10.~~ Support the reimbursement of local governments for pandemic-related expenses, including the need for essential public safety service overtime, personal protective equipment, and small business relief.
- ~~12-11.~~ Oppose measures that shift local funds to the County, State, or Federal Governments and/or make cities more dependent on the County, State, or Federal Governments for financial stability.
- ~~13-12.~~ Support policies that would increase the voter threshold for local revenue measures or would increase the potential for litigation over local taxes and fees.
13. Support efforts by the State to increase funding into the California State Controller's State Mandated Programs reimbursement program.
14. Oppose and monitor efforts that increase the City's contribution costs to CalPERS.

Economic Development

15. Support international, statewide, regional, and local efforts to attract, retain and provide resources for current and future commercial and industrial businesses.
16. Support policies and programs that encourage working with other cities, counties, and government agencies to jointly leverage resources and assets to create and strengthen economic clusters within the region.
17. Support policies, projects, programs, and regulations for diversifying Fullerton's manufacturing base and facilitating investment in the City's industrial areas that will result in maintaining or growing local jobs and creating an environment that is attractive to high-tech, research and development, business incubators, manufacturers, transportation and warehouse logistic companies, services, and other emerging industries.
18. Support economic development initiatives that preserve and enhance a positive business climate and maintain and grow the business tax base.

19. Support efforts to allow cities to recapture the true values of redevelopment and successor agency funds.

20. Support legislation that provides funding and resources to local businesses.

21. Advocate for state and regional economic development incentive programs, such as tax credits, grants, and financing programs that support business retention, expansion, and attraction.

22. Support legislation that provides funding and resources for downtown or commercial corridor revitalization, including incentives for adaptive reuse of historic or underutilized properties to support mixed use or commercial development.

23. Support alternative financing mechanisms for economic development, such as Enhanced Infrastructure Financing Districts (EIFDs), Community Revitalization and Investment Authorities (CRIAs), and Opportunity Zones. Advocate for restoring or creating a modern form of Redevelopment Agencies (RDAs) that allow cities to reinvest tax increment financing into economic development, infrastructure and job creation while maintaining fiscal accountability.

24-24. Support efforts to modernize online sales tax structures to ensure that local jurisdictions receive appropriate revenues from e-commerce transactions.

Air Quality

22-25. Support continued funding and incentives to local agencies to work together to improve air quality through the reduction of emissions and advancing economic and technical developments.

26. Support policies and guidelines to facilitate alternative building methods, materials, and technologies in accordance with the California Building Code Section 104.11.

27. Support proposals that provide funding or tools to preserve historic neighborhoods and structures.

Natural Hazards

24-28. Support programs which provide funding to hazard mitigation projects including those identified in a FEMA-approved Local Hazard Mitigation Plan.

25-29. Support legislation or funding of state efforts to create an earthquake early warning system as well as to update and prepare earthquake hazard mapping.

Solid Waste and Recycling

26-30. Support measures that maintain and enhance the local authority and economic flexibility to regulate solid waste and recyclables.

27-31. Oppose any measures that invalidate AB 939 (California Integrated Waste Management Act of 1989) indemnification and prevent cities from negotiating indemnification clauses with waste haulers as well as support measures that mandate state agencies to comply with AB 939 in the same manner as required of cities and counties.

28-32. Support legislation that will provide funding to cities that must comply with unfunded state mandates related to waste management, solid waste recycling, and organics

recycling.

Water Quality and Water Supply
