SUBJECT: DIRECTION RELATED TO POTENTIAL AMENDMENT OF COMMERCIAL CANNABIS ORDINANCE

SUMMARY

Ordinance No. 3289 related to the regulation of commercial cannabis businesses citywide took effect December 17, 2020. Based on the change of City Council Members, City Council continued an item setting fees related to cannabis activities on December 15, 2020, effectively deferring the production and release of any applications related to cannabis activities to March 16, 2021. This item seeks direction from City Council related to any potential amendment to Fullerton Municipal Code Title 3 related to commercial cannabis businesses.

RECOMMENDATION

Provide Staff direction related to amendments to Fullerton Municipal Code Title 3, specifically Chapter 3.88, related to commercial cannabis operations including, but not limited to, location of cannabis businesses by type, buffer distances, zones and other location restrictions.

PRIORITY POLICY STATEMENTS

This item matches the following Priority Policy Statements:

- Fiscal and Organizational Stability
- Public Safety.

FISCAL IMPACT

Unknown, but likely minimal fiscal impact if amendments are related to location of potential commercial cannabis businesses based on likely compliance with buffer zones which do not decrease the amount commercial cannabis licenses for each business type.

DISCUSSION

On December 15, 2020, City Council did not adopt (by a 2 – 3 vote, Silva, Zahra, Jung opposed) an urgency ordinance to stay the effective date of Ordinance No. 3289 regarding commercial cannabis businesses. At the same meeting, on a vote of 3 - 2 (Silva, Zahra opposed) City Council continued an item setting fees for issuing cannabis licenses. The continuation of the permit fees effectively prohibits dissemination of any applications for any business types and thus no person or entity can submit an application. The continuation was until March 16, 2021 in order to allow City Council to provide more direction to Staff regarding issues of concern, specifically from the two new council members who were not part of the deliberations on the ordinance.

At this time, Staff seeks City Council direction related to elements contained within Fullerton Municipal Code Title 3, specifically Chapter 3.88, which contains the substantive components of the City's Commercial Cannabis regulations. From discussion at previous City Council meetings, the regulations outlined in Section 3.88.250, Location of Cannabis Businesses by Type, is understood to be the primary Section considered for amendment. This section sets, by business type, the zones in which a commercial cannabis business is permitted in, the separation distance ("buffer zone") around a defined sensitive use, and also the amount of retail licenses per City Council District and the area south of Chapman Avenue / Malvern Avenue.

City Council direction is requested on any potential amendments. Based on City Council direction, and required noticing, Staff will look to return with any proposed amendments in proper ordinance form at either the February 2nd or 16th City Council meeting for a First Reading of the Ordinance Amendment.
