SUBJECT:	MEMORANDUM OF UNDERSTANDING BETWEEN CITY OF FULLERTON AND WISK AERO, LLC. FOR VERTIPORT INFRASTRUCTURE STRATEGIC PLANNING EFFORTS

SUMMARY

Approve Memorandum of Understanding (MOU) between City of Fullerton and Wisk Aero, LLC. This MOU will serve to establish a collaborative relationship between the two parties.

CITY MANAGER REMARKS

We have been in discussions with WISK going back to 2024 with then Mayor Dunlap.

I believe this MOU provides a unique & exciting opportunity for the City to be involved in an emerging industry.

FISCAL IMPACT

This MOU has no known or contemplated fiscal impact to the City at this time. However, the MOU states each Party shall separately bear and has sole responsibility for its costs associated with preparation, negotiation and execution of this MOU and any transaction or activity contemplated hereunder, unless otherwise agreed upon by the Parties in writing only if the entity or City agrees to perform certain work.

BACKGROUND AND DISCUSSION

Airport staff met with Wisk Aero, LLC representatives in March 2024. Wisk Aero, LLC is a leading electric vertical takeoff and landing (eVTOL) aircraft and Urban Air Mobility (UAM) technologies developer. The discussions explored the potential for introducing UAM services at the Fullerton Municipal Airport. Subsequently, Wisk Aero officials visited the airport in June 2024 and expressed interest in the Fullerton Airport as a potential candidate to host electric air taxis, also referred to as UAM.

This MOU establishes ongoing discussions and information sharing between the two parties to streamline commencing UAM operations at Fullerton Airport. The MOU has a one-year term and aims to assist Airport staff with preparing the airport for this exciting new technology. While it is non-binding and does not grant Wisk operational authority at the Airport, the MOU allows for structured, ongoing dialogue and exchange of technical information to evaluate the feasibility of UAM operations at the Fullerton Municipal Airport.
