#### **SUMMARY**

City Council introduced the first reading of an ordinance to establish a housing incentive overlay zone program and development standards and apply the "-HI" zoning designation to the Fullerton Zoning Map during the December 10, 2024 Special City Council meeting. City Council may adopt the ordinance following second reading.

ORDINANCE NO. 3335 – AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FULLERTON, CALIFORNIA, AMENDING FULLERTON MUNICIPAL CODE SECTION 15.08.020 AND ADDING A NEW SECTION 15.17.075 AND CHAPTERS 15.18 AND 15.23 RELATING TO THE HOUSING INCENTIVE OVERLAY ZONE PROGRAM ESTABLISHMENT AND RELATED DEVELOPMENT STANDARDS AND AMENDING THE OFFICIAL FULLERTON ZONING MAP BY APPLYING THE "-HI" ZONING OVERLAY DESIGNATION TO CERTAIN COMMERCIAL AND INDUSTRIAL ZONED PROPERTIES
