Mayor Dunlap opened the public hearing at 5:38 p.m.

The following addressed City Council:

- Marian Gibson expressed several concerns with the proposed overlay zone.
- Maria Rivera, Fullerton, expressed concerns with the proposed density in proximity to her home.
- Robert Jensan asked Council to consider the impact of the plan on the City.
- Karen Pascoe asked for more than 10% affordable housing.
- George Stevens highlighted issues with access to some of the proposed high-density areas and proposed alternative locations.
- Mary Francis Gable asked to maintain livability along Chapman Avenue and not go beyond the state mandates.

- Jeff Koskela asked City Council to pass only the state minimum.
- Jane Rands asked City Council to remove the Commonwealth corridor from the plan.
- Elizabeth Hansburg requested the City have enough buffer to avoid no net loss.
- Elsa McCafferty asked to add property on Highland Avenue to the Housing Element.
- Mark Freeman expressed concerns with lack of public input on development in HOIZ zones and building standards.
- David Froberg favored a greater percentage of affordable housing than proposed and high density development keeping with the Fullerton housing style.
- JJ Lashley spoke about traffic impacts and developer contributions.
- Mark Neynaber asked City Council to consider the impacts of zoning on neighborhoods.
- Jay Williams supported this item.
- Matt Leslie asked to remove the Chapman and Commonwealth corridor, preserve local control to comment on projects and increase affordable housing to 15 percent.
- Mihran Toumajan, NAIOP SoCal, spoke about unintended consequences.
- Stephanie (no last name provided) spoke about the impact of the proposed plan on her business and schools.
- Todd Harrison spoke about housing for the disabled and senior community.
- Yolanda Harrison expressed concerns with the type of housing and impacts to public safety, transit and ADA issues.
- Maureen Milton expressed concerns with the style of development and parking.
- Greg Geimont asked about school impacts and failed businesses in mixed use housing.
- Christy Sims asked City Council to include fewer properties in the overlay than proposed.
- Randy Smith, Fullerton, spoke about traffic mitigation along Chapman Avenue.
- Sean Paden opposed adding beyond the state mandates.
- Albert Hensperger asked to remove a parcel at State

College and Chapman from the overlay zone.

- Bryan Hensperger asked for no R5 zoning west of State College.
- Carime (no last name provided) supported affordable housing.
- Jane Reifer, Friends for Livable Fullerton, said this project exceeds the General Plan build out and RHNA requirements.
- Andrew Lenahan supported passing the minimum requirements.
- Julie Rayburn asked City Council to consider removing parcels in the 92832 zip code.
- Z (no last name provided) spoke about state housing mandates and campaign contributions.
- Maria Manriquez, Fullerton, spoke about traffic and pedestrian impacts and supported keeping retail parcels.
- Vinnie (no last name provided), Fullerton, opposed adding more than the minimum units.

The following addressed City Council remotely:

- Scott Hess supported approving the minimum standards.
- Ian Parker supported this item.
- Larry Bennett opposed the item as presented and suggested meeting only the minimum state RHNA numbers.
