Recommended Funding: No New Funding

Needs Addressed: Housing/Neighborhood Revitalization

Description: The Housing Rehabilitation Program maintains decent housing for Fullerton residents by providing loans and grants for home improvements. The program serves low-income families who cannot afford repairs; most of the clients are seniors. HOME funds cannot be used in the City's grant programs. CDBG is used for the grants while HOME funds are available for loans. By maintaining the individual homes, the neighborhood also benefits. With the carryover of last year's allocation of \$350,000, approximately 20 households will benefit directly from this program.

Acquisition/Rehab Project

Needs Addressed: Affordable Housing/Homeless Prevention

Description: The City will identify a CHDO to partner with to develop affordable rental housing. HOME
