Jung moved, seconded by Whitaker, to close nominations.

Motion caried 5 - 0.

Nomination of Jung for Mayor passed 3 – 2 (Opposed: Charles, Zahra).

Mayor Jung received the majority vote for Mayor for the ensuing term. City Council ceased all other nominations for Mayor.

Council Member Charles nominated Zahra for Mayor Pro Tem.

Mayor Jung nominated Whitaker for Mayor Pro Tem.

Nomination of Zahra for Mayor Pro Tem failed 2 - 3 (In favor: Charles, Zahra).

Nomination of Whitaker for Mayor Pro Tem passed 3 – 2 (Opposed: Charles, Zahra).

Mayor Pro Tem Whitaker received the majority vote for Mayor Pro Tem for the ensuing term. City Council ceased all other nominations for Mayor Pro Tem.
