



Lower your hand if you chose not to speak or after you have made your comments by unchecking the raise hand optior online.

- 3. Please state your name and city of residence at the beginning of your remarks for the minutes.
- 4. Speakers will have up to three minutes to make their remarks.
- 5. You may log off or hang up after making your comments.
