A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF FULLERTON, CALIFORNIA, DENYING VESTING TENTATIVE TRACT MAP 19342 FOR CONDOMINIUM PURPOSES FOR THE DEVELOPMENT OF 32 RESIDENTIAL TOWNHOMES ON PROPERTY ZONED R-1-20, ONE-FAMILY RESIDENTIAL (MINIMUM LOT SIZE OF 20,000 SQUARE FEET) LOCATED AT 111 WEST HERMOSA DRIVE

APPLICANT: CITY VENTURES

PROPERTY OWNER: THE NICK & MARIA CALLAS FAMILY TRUST

WHEREAS, an application was filed for a Vesting Tentative Tract Map for condominium purposes at 111 West Hermosa Drive, more specifically described as Orange County Assessor's Parcel No. 292-021-14 (the "Project"); and

WHEREAS, the Vesting Tentative Tract Map facilitates the individual sale of each unit as a residential condominium; and

WHEREAS, in compliance with the noticing requirements of Fullerton Municipal Code (FMC) Chapter 15.76, a public hearing was noticed for PRJ2024-00009, SUB-2024-0004 on February 25, 2026; and

WHEREAS, on February 25, 2026, the Planning Commission of the City of Fullerton, held a public hearing at which time it considered all evidence presented, both written and oral; and


WHEREAS, FMC Section 16.02.030 authorizes the Planning Commission to act on a Vesting Tentative Tract Map; and

WHEREAS, after the closure of the public hearing the Planning Commission directed staff by a vote of 4 to 1 to return with a resolution denying the project.

NOW, THEREFORE, the Planning Commission does hereby DENY said Vesting Tentative Tract Map SUB-2024-0004, with the following facts and reasons for said DENIAL are hereby found and declared to be as follows:

1. To deny the project based on the finding that there are safety impacts at the intersection of Hermosa Drive and Harbor Boulevard.
