SIDE LETTER OF AGREEMENT

City of Fullerton and Fullerton Fire Management Association

This Side Letter of Agreement is entered by and between the City of Fullerton (City) and the Fullerton Fire Management Association (FFMA) with respect to the following:

WHEREAS, the City and FFMA are parties to a Memorandum of Agreement (MOA) for the period of July 1, 2021 through June 30, 2023 that sets forth the compensation, hours, and other terms and conditions of employment for classifications represented by the FFMA bargaining unit;

WHEREAS, Article 7(A) of the MOA provides for the following across-the-board base salary rate increases:

Effective July 10, 2021: increase of 2.25% Effective July 9, 2022: increase of 2.25%

WHEREAS, the 2.25% salary rate adjustment effective July 10 2021 has been applied;

WHEREAS, Article 7(B) of the MOA provides for a salary increase adjustment in the event that the Fullerton Firefighters' Association (FFA) receives a cumulative salary increase in excess of 4.5% during the term of the MOA.

WHEREAS, Article 7(B) of the MOA provides that the amount of the salary increase adjustment shall be in the amount of the FFA cumulative salary increase that exceeds 4.5%:

WHEREAS, the City and FFA entered into an Agreement that provides for a 5.25% base salary increase effective the first full pay period after approval, which shall be effective on April 2, 2022.

WHEREAS, the base salary increase of 5.25% provided to the FFA now triggers the salary increase adjustment provision in Article 7(B) of the MOA:

NOW THEREFORE, the City and FFMA agree as follows:

- 1. Pursuant to the Article 7(B) of the MOA, FFMA members will receive an across-the-board salary rate adjustment of 3% effective April 2, 2022, for a cumulative salary increase of 5.25% under the term of the MOA.
- 2. No other salary adjustments shall be made during the term of the MOA, including the 2.25% salary rate increase originally scheduled to be effective July 9, 2022.
