Resolution No. PC-2025-05 adopted, recommending approval to City Council 2. LRP-2025-0008. APPLICANT: CITY OF FULLERTON:

Senior Planner Lopez presented a request to Amend Title 15 of the Fullerton Municipal Code (FMC) pertaining to regulations for Accessory Dwelling Units (ADUs) and Junior Accessory Dwelling Units (JADUs) to comply with state law.

Senior Planner Lopez pointed out an amendment on Page 4 (C. 2. a.) of Resolution No. PC-2025-05 to exempt all ADUs less than 750 square feet in size from impact fees to comply with state law and provided revised copies to Commissioners.

Chair Dino opened the public hearing at 7:05 p.m.
