## **POLICY: California Sober Living and Recovery Home Task Force** (CASLAR)

- ACC-OC provides administrative oversight for CASLAR, working to provide statewide leadership on behavioral health and recovery housing policy.
- Focus Areas:
  - Advocating for state-level regulatory standards to ensure patient safety in unregulated and for-profit sober living and group homes.
  - Supporting local control to empower cities to ensure these facilities operate safely and legally within residential neighborhoods.
  - Policy development and legislative reform during Prop 1. implementation.

## **POLICY: SoCalGas Regional Energy** Pathways Program



A partnership with SoCalGas and ACC-OC empowering Orange County cities and public sector agencies with energy efficiency solutions, technical assistance, and funding opportunities:

- Rebates & Customized Incentives
  - Financial support for energy-efficient equipment upgrades.
  - Customized incentives for large public sector customers (50,000+ therms annually).
- Energy Efficiency Third-Party Programs
  - Public Direct Install Program: No-cost & co-pay energy-saving measures for small & medium public facilities.
  - Large Public Sector (LPS) Program: Comprehensive facility assessments, project prioritization, and energy savings calculations.
- Statewide Programs & Resources
  - Instant Rebates for commercial kitchens & water heating systems.
  - Education & Training at the SoCalGas Energy Resource Center (ERC) in Downey, CA.
