- Quorum
- Agenda and Agenda Packet
- Supplemental Materials
- Addressing the Legislative Body
- Presentations and Audio-Visual Equipment
- Staff and Legislative Communications
- Consent Calendar
- Motions and Processing of Motions
- Voting
- Reconsideration
- Appeal
- Minutes
- Subcommittees and Work Groups
- Business Cards
- City Seal.

Staff prepared a draft resolution in redline format proposing the following amendments to reflect current practice and provide clarification:

Section 21: Added language regarding continued public hearing noticing.

Section 24B: Added language clarifying roll call vote order.

Staff requests City Council review the proposed Rules of Procedure and Decorum for Board, Commission and Committee Meetings.
