- **5.** You may log off or hang up after making your comments.

The Chair may request that a spokesperson represent a group wishing to address the Commission. The Chair or majority of the Transportation and Circulation Commission may grant an extension of time for a speaker. No speaker may yield their time to another speaker.

State your name and city of residence for the record at the beginning of your remarks. All speakers shall observe civility, decorum, and good behavior.
