ACTION OR DISCUSSION ITEMS

Item 1. Approval of Minutes from the Regular Meeting of January 18, 2018

Approval of the minutes was moved by Committee Member Honeywell and seconded by Committee Member Domer. The Motion carried 5-0.

Item 2. Review of Market Update and Investment Portfolio for period ending March 31, 2018

Mr. Creger presented the Market Update. The unemployment rate remained at 4.1% with wages still lagging. Housing sales picked up despite mortgage rates increasing by approximately .50% since December. The housing market was a leading indicator during the last recession, so continued monitoring is recommended. Consumer Price and Producer Price Indices

(CPI and PPI) have trended higher on a year over year basis to 2.10% and 2.70%, respectively. Gross Domestic Product (GDP) posted the strongest fourth quarter growth since 2013, but trade threats with china and other countries could slow future growth. Federal Funds rate increases and inflationary expectations have resulted in increased rates since the lows in July 2016 following the Brexit vote. Mayor Chaffee inquired about where Federal Funds rate would ultimately go, Mr. Creger responded that estimates call for two more rate hikes in 2018 and the Federal Funds rate could reach 3.5%.

Mr. Creger presented the investment report for the month of March, 2018. As of March 31, 2018, the total portfolio balance was \$102,752,201 and yielded a market gross of 2.03% with a duration of 1.30 years and a weighted maturity of 1.34 years. The current LAIF yield is 1.63%.

The 1-3 year portfolio's gross market yield was 2.31% with a weighted maturity of 1.73 which was strategically reduced to avoid interest rate risk related to rates moving higher. The portfolio was positioned to achieve the same yield as the benchmark but with less risk.

The 1-5 year portfolio's gross market yield was 2.36% with a weighted maturity of 2.41 years. Portfolio investments in the 3-5 year maturity range were strategically reduced from the previous quarter to reduce interest rate risk as well. The portfolio is primarily comprised of US Treasuries with recent exposure to CD's and additional future exposure to Corporate Notes expected.

Chair Lewczyk requested that Mr. Creger provide an update on Public Trust Advisors' recent business activities. Mr. Creger advised that 2017 was a year of continued growth for the firm and they are now managing \$26 Billion of public funds. In addition, the firm continued to add employees and has grown to 53 while at the same time ensuring that service levels remain high.

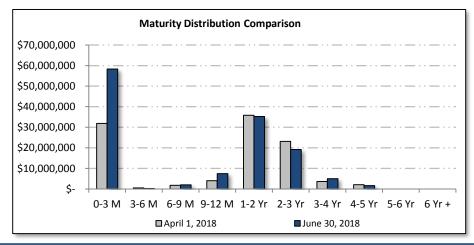

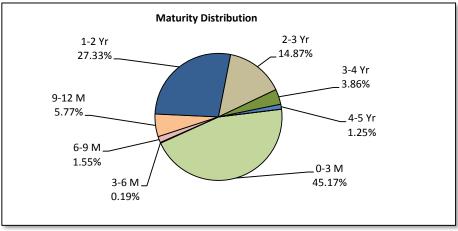

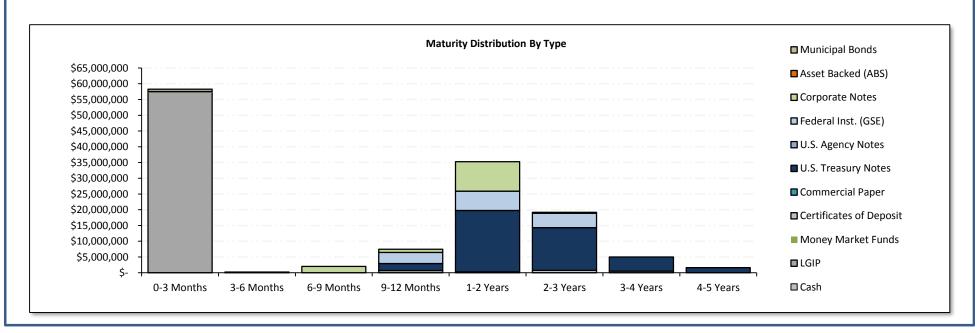






City of Fullerton Aggregate Portfolio Maturity Distribution Market Value Basis as of June 30, 2018

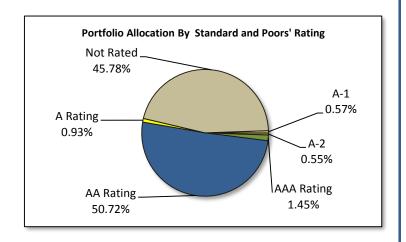
