However, all correspondence becomes part of the official record of the meeting and is posted online with the supplemental materials for that meeting.

- 4. Please state your name and city of residence at the beginning of your remarks for the minutes.
- 5. Speakers will have up to three minutes to make their remarks.
- 6. You may log off or hang up after making your comments.
