On October 5, 2021, City Council adopted Resolution No. 2021-73 which makes the legally required findings to continue to authorize remote meeting participation for legislative body members per Assembly Bill 361. - 5. Speakers will have up to three minutes to make their remarks.
- 6. You may log off or hang up after making your comments.
