On March 4, 2020, Governor Newsom proclaimed a State of Emergency in California as a result of the threat of COVID-19. On March 17, 2020, Governor Newsom issued Executive Order N-29-20 (superseding the Brown Act-related provisions of Executive Order N-25-20 issued on March 12, 2020), which allows a local legislative body to hold public meetings via teleconferencing and to make public meetings accessible telephonically or otherwise electronically to all members of the public seeking to observe and to address the local legislative body. Pursuant to Executive Order N-29-20, please be advised that some or all of the Active Transportation Committee will participate in meetings via teleconference.

PUBLIC PARTICIPATION: Pursuant to Executive Order N-29-20 and given the current health concerns, members of the public can **view meetings streamed live online at** https://fullerton.legistar.com, on Spectrum Cable Channel 3 and AT&T U-Verse Channel 99. *Members of the public may not attend the meeting in person.*

In lieu of attendance at the Active Transportation Committee meeting, the public may make oral public comments via computer, smart device or telephone by following the instructions on the next page.

CORRESPONDENCE: The public can send correspondence to the Active Transportation of Committee in advance the meeting by emailing Susana Barrios susana.barrios@cityoffullerton.com or by clicking on the eComment link accompanying the agenda posted online at https://fullerton.legistar.com Staff will forward correspondence received to the Active Transportation Committee. Correspondence is not read during public comment portion of the meeting. However, all correspondence received becomes part of the official record of the meeting and is posted online with the supplemental materials for that meeting.

- 4. Please state your name and city of residence at the beginning of your remarks for the minutes.
- 5. You may log off or hang up after making your comments.

MEETINGS: The Fullerton Active Transportation Committee meets on the third Wednesday of the month, convening at 5:00 p.m.

Those speaking on regular business items shall have no more than three minutes per item to address the Commission. No person shall speak more than one time to the same item. The Chair may request that a spokesperson represent a group wishing to address the Active Transportation Committee. The Chair or majority of the Active Transportation Committee may grant an extension of time for a speaker. No speaker may yield their time to another speaker.

PERSONS ADDRESSING THE COMMITTEE: See special notice regarding Coronavirus (COVID-19) and Active Transportation Committee meeting participation for instructions to participate in the meeting. State your name and city of residence for the record at the beginning of your remarks. All speakers shall observe civility, decorum and good behavior. Any item submitted to the Active Transportation Committee during the meeting shall become public record and subject to applicable disclosure laws.

AGENDA ITEMS: This agenda contains a brief summary of each item the Active Transportation Committee will consider. The Planning Division posts the agenda packet online no later than 72 hours prior to the meeting at www.cityoffullerton.com.

The City will post such writings and documents received in sufficient time on the City's website at www.cityoffullerton.com.
