On March 4, 2020, Governor Newsom proclaimed a State of Emergency in California as a result of the threat of COVID-19. On March 17, 2020, Governor Newsom issued Executive Order N-29-20 (superseding the Brown Act-related provisions of Executive Order N-25-20 issued on March 12, 2020), which allows a local legislative body to hold public meetings via teleconferencing and to make public meetings accessible telephonically or otherwise electronically to all members of the public seeking to observe and to address the local legislative body. Pursuant to Executive Order N-29-20, please be advised that some or all of the Active Transportation Committee will participate in meetings via teleconference.

PUBLIC PARTICIPATION: Pursuant to Executive Order N-29-20 and given the current health concerns, members of the public can **view meetings streamed live online at <https://fullerton.legistar.com>**, on Spectrum Cable Channel 3 and AT&T U-Verse Channel 99. ***Members of the public may not attend the meeting in person.***

In lieu of attendance at the Active Transportation Committee meeting, **the public may make oral public comments via computer, smart device or telephone by following the instructions on the next page.**

CORRESPONDENCE: The public can send correspondence to the Active Transportation Committee **in advance of the meeting** by emailing Susana Barrios at susana.barrios@cityoffullerton.com or by clicking on the **eComment** link accompanying the agenda posted online at <https://fullerton.legistar.com> Staff will forward correspondence received to the Active Transportation Committee. **Correspondence is not read during public comment portion of the meeting.** However, all correspondence received becomes part of the official record of the meeting and is posted online with the supplemental materials for that meeting.

ACCESSIBILITY: If requested, the agenda and backup materials will be made available in appropriate alternative formats to persons with a disability, as required by Section 202 of the Americans with Disabilities Act of 1990 (42 U.S.C. Sec. 12132) and the federal rules and regulations adopted in implementation thereof. COMPUTER / SMART DEVICE / TELEPHONE PARTICIPATION

2. **Use the “raise hand” function to join the queue to speak on the current agenda item.** (Do not raise your hand until the Chair has called the item for discussion).

You can find the raise hand option under your participant name on your computer or smart device or press star-nine (*9) on your phone to raise your hand. Press star-six (*6) to unmute.

You can lower your hand if you chose not to speak or after you have made your comments by unchecking the raise hand option online.

3. Staff will notify you when it is your turn to speak.

4. Please state your name and city of residence at the beginning of your remarks for the minutes.

5. You may log off or hang up after making your comments.

MEETINGS: The Fullerton Active Transportation Committee meets on the third Wednesday of the month, convening at 5:00 p.m.

PUBLIC COMMENT: The public may comment on matters not appearing on the agenda, but within the subject matter jurisdiction of the Active Transportation Committee. Each speaker addressing non-agenda items shall have three minutes to make their remarks.

Those speaking on regular business items shall have no more than three minutes per item to address the Commission. No person shall speak more than one time to the same item. The Chair may request that a spokesperson represent a group wishing to address the Active Transportation Committee. The Chair or majority of the Active Transportation Committee may grant an extension of time for a speaker. No speaker may yield their time to another speaker.

PERSONS ADDRESSING THE COMMITTEE: See special notice regarding Coronavirus (COVID-19) and Active Transportation Committee meeting participation for instructions to participate in the meeting. State your name and city of residence for the record at the beginning of your remarks. All speakers shall observe civility, decorum and good behavior. Any item submitted to the Active Transportation Committee during the meeting shall become public record and subject to applicable disclosure laws.

AGENDA ITEMS: This agenda contains a brief summary of each item the Active Transportation Committee will consider. The Planning Division posts the agenda packet online no later than 72 hours prior to the meeting at www.cityoffullerton.com.

In accordance with CA Government Code Section 54957.5, the public may inspect any writings or documents relating to an open session agenda item distributed after posting of the agenda packet but prior to the meeting. The City will post such writings and documents received in sufficient time on the City's website at www.cityoffullerton.com.
