Governor Newsom proclaimed a COVID-19 State of Emergency in March 2020 and issued Executive Order N-29-20 which allows local legislative bodies to hold teleconferenced meetings accessible virtually to Members and the public.

5. Please state your name and city of residence at the beginning of your remarks for the minutes.
6. You may log off or hang up after making your comments.
