The Mayor may request that a spokesperson represent a group wishing to address City Council. The Mayor or majority of the Council may grant an extension of time for a speaker. No speaker may yield their time to another speaker.

PERSONS ADDRESSING CITY COUNCIL: See special notice regarding Coronavirus (COVID-19) and City Council meeting participation for instructions to participate in the meeting. State your name and city of residence for the record at the beginning of your remarks. All speakers shall observe civility, decorum and good behavior. Any item submitted to the City Council during the meeting shall become public record and subject to applicable disclosure laws.

 - Transfer \$650,000 in approved CDBG Funds (Fund 35) to Project 55056 HOPE Center (Fund 74).
 - Transfer \$85,000 Facility Capital Repair Funds from Project 55052 Annual Facility Maintenance Projects (Fund 70) to Project 55056 HOPE Center (Fund 74).
 - Approve and appropriate \$825,000 from one of two available funding options:
 - a) Approve use of \$825,000 ARPA funds under the 'Revenue Replacement: Provision of Government Services' allowable category to Project 55056 HOPE Center (Fund 74).

OR

b) Approve and allocate \$825,000 available General Fund to Project

55056 HOPE Center (Fund 74).

- Award \$714,235 construction contract for the HOPE Center Building Improvements to Genesis Builders, Inc. and authorize the City Manager, or designee, to execute the contract in a form approved by the City Attorney.
- 4. Ratify City Manager's award of \$66,650 construction contract to Environmental Remediation Contractors, Inc. (ERC) for the abatement of asbestos and lead paint at the HOPE Center.
- Authorize Public Works Director, or designee, to approve any future change orders for construction and professional construction support services within the approved project budget.
- Approve reimbursement of Facility Capital Repair Funds (Fund 70) expended on the HOPE Center from any remaining project savings and non-grant funds upon conclusion of the project.

19. PROPOSED ARPA SPENDING PLAN FOR CITY COUNCIL CONSIDERATION

The proposed ARPA Spending Plan for City Council consideration would formally obligate its \$32.7 million American Rescue Plan Act (ARPA) funding allocation for projects and programs allowable under US Treasury guidelines. City Council has obligated \$1.45 million of ARPA funds to date. On December 7, 2021, City Council approved additional budget reductions to the Fiscal Year 2021-22 Budget and correspondingly designated \$11.9 million of ARPA funds for 'Revenue Replacement' to stabilize government finances, leaving \$19.3 million of remaining unobligated ARPA funds for projects / programs allowable under US Treasury guidelines.

Recommendation:

- 1. Ratify December 7, 2021 City Council direction and obligate and appropriate \$11.9 million of ARPA allocation for Revenue Replacement Provision of Government Services and grant City Manager authority to designate application to support stabilization of government finances.
- 2. Obligate and appropriate the remaining \$19.3 million of unobligated ARPA funds to program / project areas in accordance to US Treasury guidelines and formally approve and adopt the \$32.7 million Proposed ARPA Spending Plan.
- Authorize City Manager to manage and administer funds within respective ARPA eligible program areas to align programs or projects within the ARPA Spending Plan to comply with evolving Federal guidance and City Council priorities.
- 4. Authorize City Manager, or designee, to make necessary budget and accounting adjustments to account for and maintain financial records for ARPA funds obligated and expended to comply with US Treasury guidelines.

20. ANNUAL REVIEW OF RULES OF PROCEDURE AND DECORUM FOR CITY COUNCIL MEETINGS

City Council annually reviews its Rules of Procedure and Decorum for City Council Meetings and considers adjustments to the Rules of Procedure for future City Council meetings.
