On October 5, 2021, City Council adopted Resolution No. 2021-73 which makes the legally required findings to continue to authorize remote meeting participation for legislative body members per Assembly Bill 361. 1. OLIVE AVENUE AND CITRUS AVENUE ADULT CROSSING GUARD REQUEST

Consideration of a request for the assignment of an Adult Crossing Guard at the intersection of Olive Avenue and Citrus Avenue.

Recommendations:

- Concur with the City Traffic Engineer's proposed denial of the request for an Adult Crossing Guard.
- Concur with the City Traffic Engineer's proposed implementation of the following traffic and parking improvements:
 - A. Install all-way stop control at the Olive Avenue at Citrus Avenue intersection.
 - B. Remove 90-feet of yellow curb on the south side of Olive Avenue west of the crosswalk at Citrus Avenue.
 - C. Designate the south curb of Olive Avenue from 65-feet west of Citrus Avenue to 365-feet west of Citrus Avenue as "No Parking Student Loading/Unloading School Days" between the hours of 7:00am & 8:00am and 2:00pm & 3:00pm
 - D. Remove 175-feet of yellow curb on the south side of Olive Avenue east of the crosswalk at Citrus Avenue.
 - E. Designate the north curb of Olive Avenue from Citrus Avenue to 70-feet east of Citrus Avenue as "No Parking Student Loading/Unloading School Days" between the hours of 7:00am & 8:00am.
- Request that the City Traffic Engineer monitor traffic and parking operations along Olive Avenue for a period of 90 days to assess the effectiveness of the traffic and parking control changes and report back to the Commission on his findings.

2. ACACIA AVENUE AND CHAPMAN AVENUE ADULT CROSSING GUARD REQUEST

Consideration of a request for the assignment of an Adult Crossing Guard at the signalized intersection of Acacia Avenue and Chapman Avenue.

Recommendation:

- Concur with the City Traffic Engineer's proposed denial of the request for an Adult Crossing Guard.

3. HIGHLAND AVENUE SOUTH OF ORANGETHORPE AVENUE
TRAFFIC SAFETY AND PARKING ENHANCEMENTS

Consideration of City Traffic Engineer's recommendation to install a new all-way stop with marked crosswalks at Highland Avenue and Baker Avenue and restripe Highland Avenue south of Orangethorpe Avenue to provide marked parking spaces and additional angled parking along the west curb.

Recommendation:

- Concur with the City Traffic Engineer's proposed reconfiguration of traffic and parking controls along Highland Avenue south of Orangethorpe Avenue and recommend approval of the various proposed modifications to Council as outlined in Exhibit "A" and Exhibit "B" attached to the staff report.
