On October 5, 2021, City Council adopted Resolution No. 2021-73 which makes the legally required findings to continue to authorize remote meeting participation for legislative body members per Assembly Bill 361. City Council will continue to make this finding every 30 days. Some or all of the legislative body may participate in meetings via teleconference.

PUBLIC PARTICIPATION: The public can access live meetings at https://fullerton.legistar.com, on Spectrum Cable Channel 3 and AT&T U-Verse Channel 99.

The Council Chamber will have seating available on a first-come, first-served basis for members of the public to attend the meeting in person. All persons visiting City facilities shall observe health and safety protocols.

PUBLIC COMMENTS: The public may address the Commission in person or by joining the Zoom meeting via computer, smart device or telephone by following the instructions on the next page. Members of the public may only speak one time during public comments and on each Regular Business agenda item.

2. FULLERTON AIRPORT UPDATE

Summary: Overview of airport operations by Airport Manager Brendan O'Reilly.

Recommendation: Receive and file.

3. EARLY MORNING PARKING RESTRICTION REPEAL - 200 BLOCK OF EAST ROSSLYNN AVENUE

Summary: Consideration of a resident request to repeal the 2:00 a.m. to 5:00 a.m. "Early Morning Parking" restriction on both sides of the 200 block of East Rosslyn Avenue east of Pomona Avenue.

Recommendation: Concur with the City Traffic Engineer's recommendation and forward to City Council for approval of an exemption from the "Early Morning Parking" restriction on both sides of the 200 block of East Rosslyn Avenue, as shown in the exhibit.

4. SUNSET LANE SCHOOL NEIGHBORHOOD SAFETY ENHANCEMENTS

Summary: Consider the City Traffic Engineer's recommended implementation and modification of traffic and parking controls in the vicinity of Sunset Lane School.

Recommendation:

- Concur with the City Traffic Engineer's recommended traffic safety enhancements and recommend City Council approval of the installation of additional STOP controls at select intersections, as outlined in Exhibit B to the agenda report.
- Concur with the City Traffic Engineer's planned traffic and parking safety enhancement modifications, including installation of red zones at select intersections, as outlined in Exhibit C to the agenda report.
- Installation of parking "T"s along the south curb of Sunset Lane between El Rancho Vista and Camino Centroloma, as outlined in Exhibit C to the agenda report.
- Installation of additional "school crossing" warning signs, as outlined in Exhibit D to the agenda report.

5. CHAPMAN AVENUE TRAFFIC SAFETY REVIEW

Summary: In response to recent safety concerns expressed by the public, the Traffic Engineering Division has conducted a traffic safety review for the Chapman Avenue corridor between Raymond Avenue and State College Boulevard.

Recommendation: Concur with the City Traffic Engineer's recommendation and planned implementation of the following traffic safety enhancements for the Chapman Avenue corridor:

- At the Chapman Avenue and Victoria Drive intersection, install two high-powered LED fixtures, replace faded signs, and install yellow reflectorized backplates to improve traffic signal and pedestrian visibility at the intersection.
- At the Chapman Avenue and State College Boulevard, Acacia Avenue, and Raymond Avenue intersections, upgrade the existing safety light fixtures to higherpowered LED fixtures.
- At the Chapman Avenue and Raymond Avenue intersection, repaint or replace faded signal backplates as necessary.
- At all four signalized intersections along the Chapman Avenue corridor, upgrade pedestrian indications with countdown indications as necessary.
- At all four signalized intersections along the Chapman Avenue corridor, review and modify traffic signal timing as necessary to provide all-red intervals, minimum bicycle timing, appropriate yellow intervals, and standard pedestrian clearance intervals.
- At Chapman Avenue and Hart Place, pursue the removal of the uncontrolled crosswalk.

6. WALK ON WILSHIRE OUTDOOR DINING UPDATE

Summary: Public Works will present an update on the Walk On Wilshire Outdoor Dining Program.

Recommendation: Consider the presentation and provide comments related to the continuance of outdoor dining on Wilshire Avenue, from Harbor Boulevard westerly approximately 200-feet. In addition to allowing outdoor dining within the public right-of-way (street), consider the continued closure of said segment of Wilshire Avenue and provide comments to Council.
