FISCAL IMPACT

The Fiscal Year (FY) 2022-23 budget includes the Emergency Medical Services Manager position.

DISCUSSION

The FY 2022-23 budget includes the Emergency Medical Services Manager position. As an all-risk, all-hazard fire department, providing professional and compassionate emergency medical service is one of the primary functions. This classification will manage and provide the oversight to all Paramedics and Emergency Medical Technicians verifying that their skills and individual license requirements remain in compliance with local, county, state and federal guidelines. The Emergency Medical Services Manager provides continuing pre-hospital care education to the entire department and serves as the Infectious Control Officer. Additionally, this position will manage the public / private emergency ambulance transportation program and associated billing service.

Staff recommends assigning the Emergency Medical Services Manager to salary range 645 (\$92,036 - \$117,463) which is approximately 8% above the salary for Fire Captain and 30% below the salary for Battalion Chief.
