SB1 FUNDS ALLOCATION

ROAD MAINTANANCE AND REHABILITATION ACCOUNT (RMRA)/ SENATE BILL 1 (SB1) RESOLUTION



- On April 28, 2017 the Governor signed Senate Bill 1 (SB 1), known as the Road Repair and Accountability Act of 2017.
- SB 1 intent is to address/fund basic roadway maintenance, rehabilitation and critical safety needs.
- RMRA revenues are the result of increases in the fuel excise taxes, diesel fuel sales taxes and vehicle registration fees.
- Previous Projects:
- FY 2017-18: Chapman Ave Acacia Ave to SR-57 (Completed)
- FY 2018-19: Commonwealth Ave Balcom Ave to Acacia Ave (Construction Summer)
- FY 2019-20: Euclid St Phase 1 Williamson Ave to Fern Dr (Construction Summer)



- To receive funds, the California State Commission (CTC) requires City submit a list of proposed projects utilizing SB1 revenue by May 1, 2020.
- CTC submittal requirements include:
 - Public review of proposed projects.
 - Infrastructure and Natural Resources Advisory Committee (INRAC) reviewed and recommended this project at their February 26, 2020 meeting.
 - Use of Pavement Management Plan (PMP) to develop the list of potential projects.
 - City Council approval of Resolution identifying the list of projects.




SB1 2020/21 - PROJECT #1

- Euclid Street Fern Drive to Bastanchury Road, including;
- Valley View Place Euclid Street to Cul-de-sac
- Length of Euclid Street is approximately 0.70 mile. Valley View Place is approximately 0.10 mile.
- Current PCI on Euclid Street ranges from 27-51 and Valley View Place is 27
- Estimated roadway portion of improvement cost \$1.75M
- Extensive Water main and Sewer main replacement not required.
 - Minor work to sewer manholes and water valves will be required.
 - Water and Sewer Enterprise Funds will contribute to this minor work.
- Note: Euclid Street Williamson Avenue to Fern Drive is scheduled for rehabilitation in Summer 2020.



SB1 2020/21 - Project #1 Location Map






<u>SB1 2020/21 - PROJECT #2</u>

- Orangethorpe Avenue Woods Avenue to Highland Avenue
- Length of Orangethorpe Avenue is approximately 0.50 mile.
- Current PCI on Orangethorpe Avenue ranges from 33-37
- Estimated roadway portion of improvement cost \$940,000
- Extensive Water main replacement is not required.
 - Minor work to water valves will be required.
 - Water Enterprise Funds will contribute to this work
- Significant Sewer main modifications is expected to be included in this project.
 - Sewer Enterprise Funds will contribute to this work.
