1. PRESENTATION OF COMMUNITY SURVEY RESULTS

John Fairbanks, of FM3 Research, presented the results of a statistically valid telephone and internet-based survey conducted for the City in early November, 2019. The survey asked respondents their feelings on several matters to include various departments of the City, the City Council, and perceptions on whether the City was moving in a positive direction or not. Additionally, the survey asked respondents their perception about many different infrastructure issues, homelessness, and other items related to City programs and services. The survey also asked respondents about their

feelings towards revenue enhancement options to include a parcel tax, sales tax, and feelings toward legalization and taxation of cannabis.

- Jane Reifer, Fullerton, asked why the survey only included registered voters and if data was broken down by voting district.
- Diane Vena, Fullerton, asked about the methods used to survey respondents, the number of non-respondents and the selection of the questions used in the survey.
- Billie Holt, Fullerton, asked about the percentage of the population surveyed and selection of voters surveyed.
- Derek Johnson asked how the City would track funding directed toward homeless issues.

Recommendation:

Authorize Public Works Director to execute amendment, subject to City Attorney review, to the 2017 agreement for City Tree Services with West Coast Arborists, Inc. to enable additional operational and Capital Improvement Program project work at prices bid. Fitzgerald moved, seconded by Zahra, to direct staff to research financial policies, prepare a draft ordinance regarding the budget and a dedicated infrastructure fund, provide information on general and special sales tax measures and

research how funding will be reinvested into the community by the May 5, 2020 meeting.
