- 1) Waive encroachment permit fees for utilization of public space for outdoor dining until November 2, 2020.
- 2) Allow a reduction in on-site parking on private property for increased outdoor dining space with a property owner's

permission.

3) Authorize City Manager to make administrative adjustments to outdoor dining regulations and on-site parking requirements as needed to assist local businesses.
