### **SUMMARY**

The Police Department requests City Council approval of the 2019 Edward Byrne Memorial Justice Assistance Grant (JAG) Memorandum of Understanding (MOU) and authorization to appropriate grant funds in the amount of \$21,697.20 from the County of Orange.

### **RECOMMENDATION**

Approve Memorandum of Understanding (MOU) accept 2019 JAG award and authorize \$21,697.20 appropriation of grant funds to the Police Department Fund 32.

### **PRIORITY POLICY STATEMENT**

### **FISCAL IMPACT**

The \$21,697.20 2019 JAG allocation will enable the Police Department to update obsolete audio / visual presentation equipment in the Mural Room without impacting the General Fund budget.

### **DISCUSSION**

Federal JAG grant funds are distributed to Orange County law enforcement agencies on an annual basis and have provided funding for expenses such as equipment, supplies

and salaries for both sworn and non-sworn personnel. The MOU to Transfer Funds must be signed and submitted to the County of Orange. City Council approval is required for the 2019 JAG MOU to transfer funds in the amount of \$21,697.20.

The Police Department is proposing to allocate the 2019 JAG funds in the amount of \$21,697.20 to modernize the obsolete audio / visual presentation equipment in the Mural Room. The Mural Room is a historic room within the Fullerton Police Department headquarters and is a primary conference room for public access, is used for meetings and presentations by various units of the police department as well as hosting the FPD Citizen's Academy. The current equipment, which was approved and installed under the 2010 JAG, is in need of upgrades to effectively present audio and visual information including computer and software-generated data. The existing audio / visual equipment is ten years old, has been malfunctioning recently and cannot interface properly with the new technology. The Police Department proposed to use the 2019 JAG budget (\$21,697.20) to pay for the upgrades to the processor, touchscreen, microphone and speaker system, projector and appropriate hardware / software as needed for installation and has received authority from the Orange County Sheriff's Department.
