SUMMARY

Consideration of an ordinance amending Fullerton Municipal Code Chapter 8.46 relating to recreational vehicle parking, stopping and standing.

RECOMMENDATION

ORDINANCE NO. XXXX – AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FULLERTON, CALIFORNIA, AMENDING FULLERTON MUNICIPAL CODE CHAPTER 8.46 RELATING TO RECREATIONAL VEHICLE PARKING, STOPPING AND STANDING

PRIORITY POLICY STATEMENT

BACKGROUND

On November 17, 2020, City Council adopted Ordinance No. 3294 adding Fullerton Municipal Code Chapter 8.46 relating to recreational vehicles parking, stopping and standing. Staff proposes changes to Chapter 8.46 based upon input received from the public.

DISCUSSION

The proposed ordinance includes revisions to Chapter 8.46 based upon input received from members of the public as well as clarifying changes based upon further review of the adopted provisions by the Police Department and City Attorney's Office. The proposed changes are as follows:

- Revise the definition of "recreational vehicle" set forth in Section 8.46.020(A). The
 current definition of "recreational vehicle" is too broad and could include vehicles
 "capable" of use for human habitation, which one could unintendedly interpret to
 include standard automobiles. The proposed revised definition provides more
 specificity regarding the types of vehicles subject to Chapter 8.46.
- Make clarifying changes to Section 8.46.040(B)(2) and Section 8.46.060(D) regarding permit issuance and the permissible timeframe for use of power generators.
- Revise Section 8.46.070 to clarify that any towing of recreational vehicles for violations of the ordinance will comply with Vehicle Code Sections 22650 and 22651.
