# Background

- Required following each federal census
- Final census numbers scheduled for release late September 2021
- Process requires four public hearings
- Final map deadline - April 17, 2022
- August 17, 2021 - City Council selected Redistricting Advisory Commission option



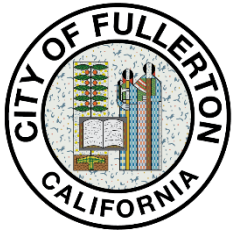
# Advisory Redistricting Commission

- Elections Code 23000 et seq
- Conducts meetings/workshops to take input
- Can conduct pre-map public hearing on behalf of the City Council
- Recommends map to City Council
- City Council holds public hearings and makes final decision on the map
- Brown Act, Public Records Act, Conflict of Interest, Rules of Decorum apply



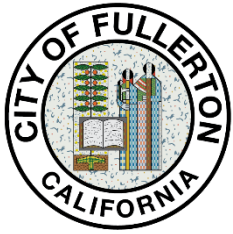
# RAC Membership

- City Council can determine manner of appointment
- Must be resident of legislative body
- Cannot be elected city official or family member, paid staff member or paid campaign staff of elected official
- In-service restrictions
- Post-service restrictions
- File Form 700

November 9, 2021 Tuesday	RAC	Workshop on Mapping, Legislation, etc.
November 30, 2021 Tuesday	RAC	Workshop on District Model, Election Sequencing
December 14, 2022 Tuesday	RAC	First Public Hearing: First drafts of committee maps, select 3 to 5 focus maps
January 11, 2022 Tuesday	RAC	Second Public Hearing: Select 2 or 3 focus maps to recommend to City council

March 1, 2022 Tuesday	CC	Fourth Public Hearing: Adopt Final Map (first reading ordinance or resolution), Election sequencing
March 15, 2022 Tuesday	CC	Second Reading Ordinance (if not adopted by resolution)
April 17, 2022 Sunday	n/a	Map Submittal Deadline
November 8, 2022 Tuesday	n/a	Election Day
