SUBJECT: PUBLIC WORKS EMERGENCY PURCHASES FY 2020-21

AND FIRST QUARTER FY 2021-22

SUMMARY

This report provides a "report of the circumstances of all emergency purchases in excess of five thousand dollars" incurred in Fiscal Year (FY) 2020-21 and through September of FY 2021-22 for Public Works operations, pursuant to Fullerton Municipal Code Section 2.64.090.

BUDGET POLICY PRIORITY STATEMENT

FISCAL IMPACT

The City made emergency purchases in FY 2020-21 and through September of FY 2021-22 per the Procurement Policy emergency provision. The appropriate funds for the respective fiscal year budgets paid for the purchases.

DISCUSSION

Emergency needs requiring immediate repair typically arise due to the City's aging infrastructure. Fullerton Municipal Code Section 2.64.090 authorizes the City Manager, or designee, to designate the emergency need and proceed with item(s) necessary for preservation of life or property and subsequently requires reporting the information to City Council.

Staff made the following emergency purchases to address City infrastructure emergency repairs including water main breaks, corresponding street repair necessitated by the water main breaks and building sewer system overflows. The emergencies also related to other failures for storm drains, well site electrical motors, sewer manholes and sewer lift stations.
