RESOLUTION NO. 2021-XX

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FULLERTON, CALIFORNIA, APPROVING MODIFICATION OF CERTAIN PARKS AND RECREATION FEES

WHEREAS, California law authorizes the City of Fullerton to collect fees and charges for services, provided such fees and charges do not exceed the reasonable cost of providing the service.

WHEREAS, it is necessary from time to time to revise the amounts charged for economical or other reasons.

WHEREAS, many City fees do not cover the current cost of providing these services.

WHEREAS, staff recommended adjusting fees to prevent the City from further subsidizing costs.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF FULLERTON RESOLVES AS FOLLOWS:

<u>Section 1</u>. City Council adopts all fees set forth in this Resolution. The Resolution will take effect immediately.

<u>Section 2.</u> This Resolution hereby amends Resolution No. 2019-25 Attachment 8, Parks and Recreation Policy Statement and Fee Schedule, as follows:
