Dunlap made a substitute motion, seconded by Whitaker, to cut the budget by five percent and dedicate \$32M of ARPA funding to roads.

Silva moved, seconded by Zahra, to adopt Package B.

Jung made a substitute motion, seconded by Whitaker, to adopt Scenario 2 with a 2% cut and change the wording to dedicate funding for streets.

Substitute motion failed 2 – 3 (In favor: Jung, Whitaker).

Original motion failed 2 – 3 (In favor: Silva, Zahra).
