MINUTES – April 18, 2018

It was moved by Chair Jones, seconded by Vice-Chair Chase, to approve the April 18, 2018 Bicycle Users Sub-Committee meeting minutes as written.

REGULAR BUSINESS

Presented

1. CALTRANS ATP CYCLE 4 GRANT APPLICATION
UPDATE

Planning Manager Foulkes shared the design plans for the Active Transportation Program (ATP) Cycle 4 grant through Caltrans which allows for final design and construction costs with no local match

required. The project being applied for this cycle are the improvements to Yorba Linda Boulevard and Nutwood Avenue.

Nutwood Avenue improvements include:

1. Addition of a buffered Class 2 bicycle lane along Nutwood Avenue from Placentia to State College Boulevard on both sides of Nutwood Avenue.
2. Adding conflict zone markings at driveways and intersections.
3. Adding bicycle bend-outs at locations with dual threats (combined with special bicycle signal phasing at those locations).
4. Adding high visibility pedestrian crossings.
5. Modification to accommodate the required width in the area directly under the SR 57 freeway by cutting into the existing slope and installing retaining walls without impacting bridge footings.
6. Retaining existing lane configurations (lane width reduced), number and length of turn pockets.

Yorba Linda Boulevard improvements include:

1. Removing center median to accommodate travel lanes + Class 2 bike lanes on both sides of Yorba Linda Boulevard.
2. Installing eastbound buffered bike lane between Associated Road and SR 57 southbound ramps.
3. Transition westbound Class 2 bike lane to sharrows approaching Associated Road.
4. Conflict zone markings and high visibility crosswalks for pedestrians.
5. Improvements extended on the east side to Deerpark Drive to capture connectivity at the west end of the corridor to the CSUF campus to University Shopping Center.
6. "Squaring up" the loop ramps for the eastbound to north SR 57 on-ramp and

westbound to south SR 57 on-ramp.

7. No change to west (northbound on-ramp which would likely also require modified access to the freeway mainline and might add the need for auxiliary lanes to the freeway.

Final design and improvements will be determined should the grant be awarded to the City.

Planning Manager Foulkes shared an update on his work with Paul Martin from the Orange County Transportation Authority (OCTA) who is working to develop a more regional approach to bike share in Orange County.

3. WILSHIRE AVENUE BIKE BOULEVARD UPDATE

Planning Manager Foulkes announced that construction on the Wilshire Avenue Bike Boulevard project began on July 16, 2018 between Lemon Street and Berkeley Avenue and shared information regarding crossings, parking, traffic circles and landscaping.

STAFF / COMMITTEE COMMUNICATION / FUTURE AGENDA ITEMS

Planning Manager Foulkes announced the following City Council action taken July 17, 2018:

- Citywide Bicycle and Pedestrian Improvement Project Bid rejection at staffs request due to error in bid document; correction will be made then resubmitted
- Bicycle Users Sub-Committee will be replaced with the Active Transportation Committee effective January 1, 2019 with reduction in members from seven to five

Sub-Committee Member Rector shared the opening of the Daisy-Myrtle Bicycle Boulevards project in Long

Beach.

Sub-Committee Member Buck would like to agendize the discussion of green paint use on bike lanes and requested an update on the path behind Loma Vista Memorial Park.

Chair Jones announced a Special Meeting of the Transportation and Circulation Commission on Monday, July 23, 2018 at 6:00 p.m. regarding parking circulation in the downtown area.

The next Bicycle Users Sub-Committee meeting will be held on August 15, 2018 at 5:00 p.m., in the Council Chamber, 303 West Commonwealth Avenue, Fullerton, California.
