 APPLICANT AND PROPERTY OWNER: RICHARD WOLFENSTEIN

Assistant Planner Caldera provided a staff report regarding a request for a Variance and a Major Site Plan to construct a single-family residence that exceeds the maximum permitted number of stories, building height, and building area allowable on a second story on property addressed 1300 Ridgeview Terrace (south end of Ridgeview Terrace, 320 feet south of Skyline Drive).

Chair Gaarder opened the public hearing at 6:45 p.m.

Richard Wolfenstein, Fullerton Resident, referenced the design of the house and responded to questions from the Planning Commission.

Brian Naranjo, Fullerton Resident, spoke about reducing the height of the proposed three-story house from 32 feet to 30 feet.
