#### PUBLIC COMMENTS

#### APPROVAL OF MINUTES

It was moved by Sub-Committee Member Buck, seconded by Sub-Committee Member Maus, to approve the March 20, 2019 Bicycle Users Sub-Committee meeting minutes as written. The May 22, 2019 meeting was cancelled due to a lack of quorum.

#### REGULAR BUSINESS

1. UPDATE ON DOWNTOWN ACTIVE TRANSPORTATION PLAN

Planning Manager Foulkes announced that Fullerton was selected to receive a \$200,000 grant from the

Southern California Association of Governments (SCAG) for the preparation of a planning grant for active transportation with a focus on the downtown area. Planning Manager Foulkes noted that a detailed level design will enable Fullerton to go after active transportation planning grants through California Department of Transportation (Caltrans), bicycle corridor improvement grants through Orange Transportation Authority (OCTA), and federal grants.

Mr. Foulkes also shared that the Wilshire Avenue Bicycle Boulevard has been completed and the citywide bicycle/pedestrian plan grant is being wrapped up.

### Q&A WITH THE CITY OF FULLERTON PUBLIC WORKS DIRECTOR – MEG MCWADE

Public Works Director McWade provided BUSC members with materials covering pavement condition, funds we have to invest in the roads, a general overview of Public Works-Engineering, and maps of projects underway or being planned. McWade stated that they are currently working with the Infrastructure and Natural Resources Advisory Committee (INRAC) on an assessment of all of the City's infrastructure as well as how to potentially fund it.

Public Works Director McWade explained the Pavement Condition Index (PCI) map and the balancing act required due to the needs far exceeding the pace of revenues coming in.

# STAFF / COMMITTEE COMMUNICATION / FUTURE AGENDA ITEMS

Sub-Committee Member Buck asked if BUSC will become the Active Transportation Commission (ATC). Planning Manager Foulkes responded that the Resolution has been drafted and the Staff Report is with the City Clerk's office. He will follow-up with the Clerk as to when the City Manager and City Clerk will agendize this for a City Council Meeting.

Sub-Committee Member Buck inquired about feedback on the Wilshire Bike Boulevard roundabouts. Planning Manager Foulkes responded that Highland Avenue has been drawing the most concern and there are occasional comments regarding Malden Avenue.

Sub-Committee Member Avila asked for an update on the bike and scooter share program. Planning Manager Foulkes stated that we are still working with California State University, Fullerton and that Spin scooter-sharing company is the most recent one he has been in contact with.

Chair Chase asked about plans for reverse in angle parking on Pomona Avenue. Planning Manager Foulkes responded that Pomona Avenue has been identified as a potential area for reverse in angle parking in the implementation of the Bicycle Master Plan from Commonwealth to Whiting Avenues.
