Senior Civil Engineer Grantham advised that there will be a "State of the Streets" presentation at the July 16, 2019 City Council Meeting. He also briefly discussed the recent increase in letters from residents inquiring about the City's liability for vehicle damage sustained while driving on City streets, as well as the Bicycle Users Sub-Committee's request that INRAC consider including bicycle lanes in any prioritization list that may be developed.
