CALL TO ORDER

The meeting was called to order at 7:30 a.m.

PUBLIC COMMENTS

2. INFRASTRUCTURE ASSET PRIORITIES/REPORT

Staff Member Grantham reviewed the Infrastructure Asset Funding Priorities Chart and received feedback from Committee Members.

3. PAVEMENT MANAGEMENT PLAN (PMP) SCENARIOS

Committee Members reviewed Bucknam Infrastructure Group's July 17, 2018 draft report, "Additional Pavement Management Program Reporting – Conditional Outcomes Based Upon Sales Tax Increases." Members discussed the Resulting PCI Findings chart and recommended various revisions.

4. INFRASTRUCTURE REPORT SCHEDULE

Staff Member Grantham discussed the proposed schedule for completing the Infrastructure Asset Report and received feedback from the Committee.

Committee Members cancelled the regularly-scheduled meeting on December 25, 2019 and scheduled a special meeting on December 18, 2019. Members also requested a special evening meeting in January to receive feedback from the public on the draft report and presentation.

STAFF/COMMITTEE COMMUNICATION

Staff Member McWade advised that Staff met with consultants Mike Whipple and Stephen Bucknam about updating a previous study on available funding options, and they will be providing a proposed scope and schedule in the next week.

Chair Sandford asked Staff to contact B&A for an estimate of the average annual amount Fullerton could expect to obtain from grants related to infrastructure and an estimate of the necessary matching contributions from the City.

Chair Sandford provided direction to Member Sebourn on the City budget portion of the Infrastructure Asset Report, and Members briefly discussed potential recommendations.

Member McNelly asked for a future agenda item to discuss recycling and waste management with a representative from Republic Services.

Staff Member McWade provided a brief update on PFOA and PFAS testing and next steps in the process.
