1. MINUTES – February 5, 2020

2. SB 1 FUND PROJECT FY 20-21

Staff Member Grantham provided a brief presentation on the proposed use of SB 1 funds for Fiscal Year 2020-21.

Shapiro moved, seconded by Tutor to support Staff's recommendation that City Council approve the use of SB 1 funds for the rehabilitation of Euclid Street (Fern Drive to Bastanchury Road) and Orangethorpe Avenue (Woods Avenue to Highland Avenue).

Motion carried 9-0.

3. COMMITTEE RULES

Sebourn moved, seconded by McNelly to approve the Infrastructure and Natural Resources Advisory Committee Rules and Procedures, dated January 2020.

Motion carried 9-0.

4. ONE-TIME REVENUE PROJECTS

Staff Member Grantham provided a status update on the street improvements that were funded from the sale of City property and Rule 20A allocations, approved by City Council on April 2, 2019.

5. INFRASTRUCTURE FINAL REPORT

Members discussed the Infrastructure Conditions and Funding Report and presentation.

Shapiro moved, seconded by Sebourn, to support the final report with the requested revisions.

Motion carried 9-0.

Members requested that the INRAC report be presented to City Council independent of the Community Survey. Staff Member Castro-Graham noted that the Community Survey would be a separate item.

Members discussed possible alternative recommendations, but no action was taken.
