REGULAR BUSINESS

 OVERVIEW OF COVID-19 IMPACTS TO CURRENT FISCAL YEAR REVENUE AND PROJECTS

Staff Member Grantham presented a memo, dated April 20, 2020, detailing possible revisions to the F.Y. 2019-20 and 2020-21 CIP budgets to account for reductions in revenue due to COVID-19. He noted that information on projected revenue is constantly changing; as such, the F.Y. 2020-21 CIP Budget should be considered a spending plan for capital improvements that is dependent upon the amount of revenue generated and received during the fiscal year. Staff answered questions from Committee Members.

McNelly moved, seconded by Tutor to provide conditional approval for the proposed F.Y. 2020-21 CIP budget, as presented, for Street Improvements, Sewer, Storm Drain, and Water.

Motion carried 6-2-1 (No: Carvalho, Dino; Absent: Sebourn)

Members Carvalho and Dino stated that streets need to be a priority, and there should be some contribution toward street rehabilitation and repair from the General Fund. Member Tutor also stated that streets should be a priority for funding, and she requested regular updates on the CIP budget to monitor any changes.

 DRAFT CAPITAL IMPROVEMENT PROGRAM (CIP) BUDGET FY 20-21 REVIEW – Cont'd

Staff Member Grantham discussed the F.Y. 2020-21 proposed projects under Traffic Signal and Street Lighting. Several Committee Members asked if funds could be pulled from less critical Traffic Signal and Street Lighting projects and put towards street rehabilitation and repair. Chair Sandford asked Staff Member Grantham to consider the Committee's requests and bring proposed revisions to the next meeting.
