2. SALES TAX BALLOT MEASURE UPDATE

Please attend Fullerton City Council meeting to support Community Choice Aggregation and ask Fullerton City Council vote in favor of joining Irvine's invitation to form a JPA to administer the program."

Staff Member Castro-Graham noted that City Council directed staff to move forward with discussions with the City of Irvine regarding Community Choice Aggregation, but any actions having a fiscal impact on the City will need to be approved by Council prior to implementation.

4. WATER RATE FEE PROJECT IMPLEMENTATION REVIEW

She and Staff Member Grantham provided an update on the water CIP projects and answered questions from the public and Committee Members.
