5. UNION PACIFIC TRAIL UPDATE

Deputy Director Loya gave a PowerPoint Presentation giving an overview of the Union Pacific Trail project. She explained the history of the trail and how it will benefit other projects and the benefits the residents will be able to take advantage of having a trail in their neighborhood.

Commissioner Lloyd asked if having a bike patrol will be an additional cost to the Department, Deputy Director Loya said it will not. Chair Wehn asked what makes the project cost \$2 million, Deputy Director Loya explained that the trail is long and parts of the project such as concrete are expensive, but the funding will come from grants. Commissioner Lira asked what the upkeep will be like and Deputy Director Loya responded by saying the plans that have been created for the project will not require much maintenance and the plants will be drought tolerant.
