The meeting was called to order at 5:00 p.m.

1. DRAFT FY 2021-22 CIP BUDGET REVIEW, Cont'd

Member Bharadwaja arrived at 5:03 p.m.

Staff Members Grantham, Foo, and Huang discussed the proposed F.Y. 21-22 CIP projects for the Water System and answered questions from Committee Members.

During the discussion of the PFAS Management project, Member Hagekhalil noted the importance of operational maintenance and asked that City Council make this a priority as they appropriate funds in future budgets.

Resident Jane Reifer referenced the Water Main Replacement FY 2021-22 – 2025-26 map and asked if the mains highlighted in south Fullerton are scheduled for replacement. Staff members Grantham and McWade responded.

Shapiro moved, seconded by Tutor to support the recommended CIP F.Y. 21-22 budget for Water System projects.

Motion carried 7-0-2 (Absent: Chong and McNelly).

Member Shapiro asked for a presentation from OCWD or MWD to discuss the potential future drought situation and the impacts to Fullerton rate payers.

Staff Members Huang and Foo left the meeting (via teleconference) at 5:36 p.m.

Staff Members Grantham and Loya discussed the proposed F.Y. 21-22 CIP projects for the Parks and Recreation Department and answered questions from Committee Members.

In response to Vice Chair Alcantara's comments, Staff Member Loya advised that she will make a note in the Parks & Recreation Commission staff report that INRAC recommended approval of the projects.

Tutor moved, seconded by Dino to support the recommended CIP F.Y. 21-22 budget for Parks and Recreation Department projects.

Motion carried 7-0-2 (Absent: Chong and McNelly).

Staff Member Loya left the meeting at 6:05 p.m.

Staff Member Grantham presented the proposed F.Y. 21-22 CIP projects for Public Works Department – Maintenance Services and answered questions from Committee Members.

Alcantara moved, seconded by Dino to support the recommended CIP F.Y. 21-22 budget for Public Works Department – Maintenance Services projects.

Motion carried 6-0-3 (Absent: Chong, Hagekhalil and McNelly).

Staff Member Grantham presented the proposed F.Y. 21-22 CIP projects for Street Improvements and answered questions from Committee Members.

Member Hagekhalil returned to the meeting at 6:30 p.m.

Alcantara moved, seconded by Shapiro to support the recommended CIP F.Y. 21-22 budget for Street Improvements projects.

Motion carried 7-0-2 (Absent: Chong and McNelly).
