- Jane Rands, Fullerton, suggested HIOZ (Housing Incentive Overlay Zone) and Religious Surplus Land affordable percentages be increased as well as a breakdown of the three ranges of affordability.
- Maureen Milton, Fullerton, inquired whether religious organizations have been presented with the idea to build

- senior housing they can profit from while being of service to the community on Religious Surplus Land.
- Jane Reifer, Fullerton, proposed implementing score cards for every building project to see whether project provides affordable units and encouraged the City to adopt a stand-alone inclusionary housing program.
- Ernie Kelsey, Fullerton Heritage, would like to see more Preservation zones in the City.
- Scott Hess, Fullerton, inquired if property owners in the HIOZ were notified of tonight's Planning Commission meeting and about obtaining a detailed map with parcels.

Chair Cox closed the public hearing at 7:15 p.m.

It was moved by Chair Cox, seconded by Commissioner Carvalho, to continue this item to a date uncertain.
