Consideration of Downtown nighttime paid parking pilot program operational parameters including Professional Services Agreement with SP+ for parking management services, consideration of budget adjustments related to procurements by SP+ and introduction of an ordinance to expand parking citation authority.

Recommendation by the Community Development Department:

- 1. Authorize City Manager to execute Professional Services Agreement with SP+ for parking management services.
- 2. Approve scope and costs for management and implementation of Downtown nighttime paid parking pilot program.
- 3. Appropriate \$55,050 from General Fund and recognize \$28,500 additional revenue for Fiscal Year 2018-19.
- Adopt Resolution No. 2019-XX.
