## THE PINES AT SUNRISE VILLAGE REDEVELOPMENT - ROSECRANS AVENUE AND EUCLID STREET

The Planning Commission voted 4 - 1 to recommend City Council approval of this project, including demolition of the existing on-site uses and construction of a residential community with detached and attached single-family residential homes.
